Merger between Kværner ASA and Aker Solutions ASA

Assistance to listed Norwegian contractor group Kværner ASA on the merger between Kværner ASA and Norwegian listed oil services group Aker Solutions ASA. The combined company will have about 15 000 employees in more than 50 locations around the world. It will have about 8 000 employees in Norway.
